

## Health/Sale Guarantee

This health guarantee is between (seller) HardDrive American Bulldogs and (buyers)\_\_\_\_\_ on this\_\_\_\_\_ day of \_\_\_\_\_ . This is a replacement only guarantee, no cash refunds. We guarantee our puppies to be free of " Genetic Defects" such as Hip Dyspepsia or any other "life threatening" defects for up to 2yr. You have 48 hr.s (or 2 business days) to have the puppy vet checked after the puppy is in your care. You will need to send us a copy of the vet cert. saying the puppy is in good health.

This guarantee will be VOID if any of the following things have occurred to the dog:

- 1) Neglected in any way
- 2) Has not had ALL puppy shots and routine vet care
- 3) Has been weight pulled (before one year )
- 4) Abused in any way
- 5) If the dog has been bred (Male or Female , Accident or by choice) before the one year.
- 6) Used for Fighting
- 7) If the puppy has not been taken to the vet within the 48 hrs. of the new owners care.

If the said dog is found to have Hip Dysplasia or any other life threatening problem , then all vet reports , Penn Hip reports must be given to Seller at time of claim. After you have sent us proof of Hip Dysplasia or other life threatening problem , and proof of said dog being spayed or neutered , you will be able to get a replacement puppy , you will not have to return said puppy to us as long as you send us proof of it being spayed or neutered .

All vet bills and shipment cost are to be taken care of by buyer.

HardDrive American Bulldog's WILL NOT be responsible for any vet bills or shipment cost !! We are not guaranteeing that our puppies will be breeding or show quality puppies , so only life threatening issues will result in a replacement puppy of equal value. Of equal value meaning that your original purchase price will be applied towards the purchase price of your replacement puppy, Example your first puppy is purchased at pet price but you decide on your replacement pup that you want full breeding rights then your original purchase price will be deducted from the purchase price of the replacement puppy and you will be responsible for paying the difference in the two prices.

You have up to 1 year or 2 litters whichever comes first, from the date the defect was found to decide on your replacement puppy. If you have not decided on your replacement puppy by then you forfeit your right to a replacement pup.

The puppy must be seen by your Veterinarian with in 48 hrs of being with new owners.

HardDrive American Bulldogs gets the first choice to take dog / puppy back if buyer decides to re home the animal.

The Suffix or Prefix "HardDrive" must be carried on all puppies bought from HardDrive American Bulldogs on any and all registration papers .

The Buyer agrees to provide the dog with the proper exercise, diet, shelter and general care and properly maintain adequate accommodations for an American Bulldog considering its size and weight. The Buyer further agrees to provide regular veterinary care including checkups, booster vaccinations and any other care needed by the dog (e.g. regular worming, illnesses, injuries, ect). The Buyer also agrees that the dog shall be maintained and kept under Buyer's control at all times and not allowed to run at large (with possible exception of under direct supervision and control of owner). There are many factors that can influence growth and development of a large breed dog, such as diet, exercise, weight gain, proper veterinary care, etc. The Buyer agrees to complete the appropriate vaccinations, give the dog regular and appropriate exercise, and feed the dog appropriately. The Buyer agrees to properly train and socialize the dog.

The Buyer acknowledges that the American Bulldog is a large and powerful breed, is familiar with the traits of the American Bulldog and is cognizant of the importance of training and socialization. The Buyer agrees that he/she bears responsibility for the training and socialization of the dog, and responsibility for the safety of the dog and others with whom the dog interacts. The Buyer accepts all risks and responsibilities for owning the dog and acknowledges that he/she has the sole responsibility for ongoing, lifetime socialization and training for the dog as appropriate for its age and level. If at any time, there is neglect, abuse or illegal activity involving this canine, said canine is subject to immediate forfeiture to the Kennel.

In the event of breach of this agreement, the Buyer agrees to pay all expenses of retaking, holding, preparing for sale, selling, and expenses as may be allowed by the law and incurred by the seller in enforcing his/her rights under this security agreement. The dog may be subject to forfeit if the Buyer does not fulfill his/her obligations. All legal proceedings will take the place in the county of Wood in the state of West Virginia, the residence of the breeder, and this contract is valid the entire life of the canine unless transferred to a subsequent owner.

You can send a non-refundable deposit to hold pick spot in the litter, puppies must be paid in full by the age of six weeks old or if your having the puppy shipped it has to be paid in full at lest 5 days before said pup can be shipped , if said puppy is not paid in full by the age of 8 weeks your deposit will be forfeited and the puppy will be placed back up for sale!
